

## LICENSING AND REGULATORY INFORMATION

Arch Insurance Company (a Missouri corporation, NAIC Number 11150) is licensed as an insurer in all 50 states, the District of Columbia, Puerto Rico, Guam and the U.S. Virgin Islands. Arch Mortgage Assurance Company (a Wisconsin corporation, NAIC number 29114) is licensed in 42 states and the District of Columbia. Arch Specialty Insurance Company (a Missouri corporation, NAIC Number 21199) is licensed in the state of Missouri and is eligible as an excess and surplus lines insurer in all other states, the District of Columbia, Puerto Rico and the U.S. Virgin Islands. Arch Reinsurance Company (a Delaware corporation, NAIC Number 10348) is a licensed, accredited or otherwise approved reinsurer in all 50 states, the District of Columbia, Guam and Puerto Rico, and its reinsurance operations in Canada are conducted through its Canada Branch.
