## CA AB1305 Information

### Overview of Legislation

California's AB1305 legislation requires organizations with operations in California that buy or sell voluntary carbon offsets, or make net zero and carbon neutrality claims, to disclose specific information about these offsets and sustainability commitments. This legislation aims to provide transparency around how companies offset their emissions and how they measure progress toward achieving their net zero and carbon neutrality claims.

The information in Sections A and B below must be disclosed by January 1, 2024.

## A. Disclosure Requirements for Organizations Making Net Zero & Carbon Neutrality Claims

### If a company claims...

- · net zero emissions.
- · claims to be, or have a product that is "carbon neutral"
- · claims that the company or product does not add net GHG to the climate
- · claims that the company or product has made significant reductions
- ...the company shall disclose on its website the following information:
- 1. All information documenting how, if at all, a "carbon neutral," "net zero emission," or other similar claim was determined to be accurate or actually accomplished, and how interim progress toward that goal is being measured. The above information may include:
- · disclosure of independent third-party verification of all of the entity's greenhouse gas emissions,
- identification of the entity's science-based targets for its emissions reduction pathway.
- · disclosure of the relevant sector methodology and third-party verification used for the entity's science-based targets and emissions reduction pathway.
- 2. Whether there is independent third-party verification of the company data and claims listed.
- 3. This part of the legislation does not apply to entities that either do not operate within California, or that do not make claims within the state.

## B. Disclosure Requirement for Organizations Buying Voluntary Carbon Offsets

If a company claims...

- · the achievement of net zero emissions
- · that it, a related entity, or a product is "carbon neutral"
- that it, a related entity, or a product does not add net carbon dioxide or greenhouse gases to the climate or has made significant reductions to its carbon dioxide or greenhouse gas emissions
- ...the company shall disclose on its website all of the following information pertaining to each project or program:
- 1. The name of the business entity selling the offset and the offset registry or program.
- 2. The project identification number, if applicable.
- 3. The project name as listed in the registry or program, if applicable.
- 4. The offset project type, including whether the offsets purchased were derived from a carbon removal, an avoided emission, or a combination of both, and site location.
- 5. The specific protocol used to estimate emissions reductions or removal benefits.
- 6. Whether there is independent third-party verification of company data and claims listed.
- 7. This part of the legislation does not apply to entities that do not operate within California or do not purchase or use voluntary carbon offsets sold within the state.

#### 2. Please describe how your organization is measuring progress towards its net zero or carbon neutral goal(s). For the net zero and carbon neutral goal(s) your organization has achieved, please detail the ways your organization ensures it continues to meet these achievements.

In 2022, Arch Capital Group Ltd. (ACGL) first announced carbon reduction and net zero goals. We committed to reducing our absolute Scope 1 and Scope 2 GHG emissions by 42% by 2030 from a 2020 baseline. ACGL also committed to achieving net zero operations by 2030, in part supported by the purchase of carbon removal offsets for our remaining Scope 1 and Scope 2 emissions. Conducting annual greenhouse gas assessments, including assessing achieved emissions reductions, helps the company measure and report on progress toward these goals. Our decarbonization strategy includes the sourcing of regovable enemy for our operations, and the progressent of enemy efficiency reportune for our offices and data centers.

ACGL has sourced carbon offsets since 2019. In our 2022 Sustainability Report (https://www.archgroup.com/wp-content/uploads/Arch-Sustainability-Report-2022.pdf), we state that we purchase carbon active has sourced authorit orises since 2015.
